

# AGREEMENT TO SPEND TOWN HIGHWAY FUNDS

TOWN OF West Sparta  
COUNTY OF Livingston

Pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected for the repair and improvement of highways, and received from the state for the repair and improvement of highways, shall be expended as follows:

1. GENERAL REPAIRS. The sum of \$~~37,000~~ <sup>65,000 Add D.M.M.</sup> may be expended for general repairs upon 30 miles of town highways, including sluices, culverts and bridges having a span of less than five feet and boardwalks or the renewals thereof.

2. IMPROVEMENTS. The following sums shall be set aside to be expended for the improvement of town highways:

(a) On the road commencing at Coffee Hill (Millard Filmore) and leading to Stoner Hill rd., a distance of 1.26 miles. there shall be expended not over the sum of \$ 76,000.00

Type Full depth Reclamation Width of traveled surface 22 FT.

Thickness 10" Subbase Gravel

Chips

(b) On the road commencing at Presbyterian (moore rd north) and leading to Dead End, a distance of 1.2 miles. there shall be expended not over the sum of \$ 15,500.00

Type Asphalt Surface Width of traveled surface 22 FT.

Thickness 1" Subbase Asphalt

Chips

(c) On the road commencing at RT 63 Bridge (Appleville rd) and leading to Everman rd., a distance of .25 miles. there shall be expended not over the sum of \$ 4,800.00

Type Surface Treat Width of traveled surface 22 FT.

Thickness 1" Subbase Asphalt

Chips

No moneys set aside for such improvements shall be expended, nor shall any work be undertaken on such improvements until the Town Superintendent approves the plans, specifications and estimates for such construction.

This agreement shall take effect when it is approved by the Town Board.

2. IMPROVEMENTS. The following sums shall be set aside to be expended for the improvement of town highways:

(a) On the road commencing at Route 36 (Hackman rd) and leading to Dead end, a distance of 0.29 miles. there shall be expended not over the sum of \$ 15,500.00  
Type Surface Treatment Width of traveled surface 22 FT. MMV W.M.M.  
Thickness 1" Subbase Gravel

(b) On the road commencing at Rock Spring (Preston rd) and leading to Dead end, a distance of 0.36 miles. there shall be expended not over the sum of \$ 11,000.00  
Type Surface Treat Width of traveled surface 22 FT  
Thickness 1" Subbase Gravel

(c) On the road commencing at Route 36 (Sullivan Rd) and leading to Dead end, a distance of 0.31 miles. there shall be expended not over the sum of \$ 12,500.00  
Type Surface Treat Width of traveled surface 22 FT. MMV W.M.M.  
Thickness 1" Subbase Gravel

No moneys set aside for such improvements shall be expended, nor shall any work be undertaken on such improvements until the Town Superintendent approves the plans, specifications and estimates for such construction.

This agreement shall take effect when it is approved by the Town Board.
