AGREEMENT TO SPEND TOWN HIGHWAY FUNDS

20:

TOWN OF West Sparta

COUNTY OF Livingston

Pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected for the repair and improvement of highways, and received from the state for the repair and improvement of highways, shall be expended as follows:

Total \$114,000

+\$44,000 Roll over Funds

1. GENERAL REPAIRS. The sum of \$ 70,000 may be expended for general repairs upon _____ miles of town highway including sluices, culverts and bridges having a span of less than five feet and boardwalks or the renewals thereof.

2. IMPROVEMENTS. The following sums shall be set aside to be expended for the improvement of town highways:

- (a) On the road commencing at Nunda-Byersville and leading to Redmond Rd (CNTY #13), a distance of 1.31 miles, there shall be expended not over the sum of \$ 25,000.00

- (b) On the road commencing at Presbyterian and leading to Pauline Rd, a distance of .76 miles, there shall be expended not over the sum of \$ 22,000.00

- (c) On the road commencing at Rockspring Rd (CNTY #11) and leading to Redmond Rd (CNTY #13), a distance of 1.5+ miles, there shall be expended not over the sum of \$ 55,154.00

Repair Bad SPOTS - chip seal 1.5 miles +

No moneys set aside for such improvements shall be expended, nor shall any work be undertaken on such improvement until the Town Superintendent approves the plans, specifications and estimates for such construction.

This agreement shall take effect when it is approved by the Town Board.
